KALAMAZOO COLLEGE TAX DEFERRED ANNUITY PLAN

This is a summary of the annual report for the KALAMAZOO COLLEGE TAX DEFERRED ANNUITY PLAN, (Employer Identification No. 38-1358014, Plan No. 002) for the period January 1, 2010 to December 31, 2010. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

BASIC FINANCIAL STATEMENT

Benefits under the plan are provided by a trust (benefits are provided in whole from trust funds). Plan expenses were \$668,613. These expenses included \$668,613 in benefits paid to participants and beneficiaries. A total of 285 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$12,216,771 as of December 31, 2010 compared to \$10,882,943 as of January 1, 2010. During the plan year the plan experienced an increase in its net assets of \$1,333,828. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. The plan had total income of \$2,002,441, including employee contributions of \$438,181 and earnings from investments of \$989,811.

The plan has a contract with TIAA-CREF which allocates funds toward group deferred annuities.

You have the right to receive a copy of the full annual report, or any part thereof, on request. The items listed below are included in that report:

1. An accountant's report;
2. Assets held for investment;
3. Insurance information including sales commissions paid by insurance carriers; and
4. Information regarding any common or collective trust, pooled separate accounts, master trusts or 103-12 investment entities in which the plan participates.
